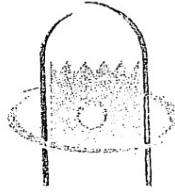

When preparing the tender documents, the disposing party must include in the documents the criteria for comparison between bids and the relative weights mentioned in the tables attached to this decision, according to the type and nature of each

tender

Article Three

In the event that the criteria and relative weights mentioned in the comparison criteria attached to this decision are not valid or inappropriate for the nature of the project to be tendered, the disposing entity must, before issuing the tender, submit proposed criteria and relative weights appropriate to the type and nature of the tender to the Council for review, approval and approval, and then include them in the documents. Tender.

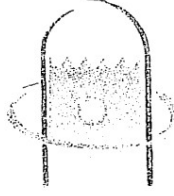

Follow Resolution No. (1) of 2010 regarding criteria for comparing bids

Article Four

After the envelopes are opened by the Council and the bids are referred to the managing authority for evaluation, the managing authority evaluates the bids according to the comparison criteria and their relative weights specified in the tender documents, and the bid with the best terms and lowest price is determined by adding the points obtained from the result of the technical evaluation and the financial evaluation together.

Article Five

In the event that the points obtained for more than one supplier or contractor are equal, the lowest priced bid will prevail if it meets the technical and other criteria.

Article Six

At the end of the evaluation process, the acting authority shall submit a comprehensive report to the Council on the results of the evaluation, containing the points obtained by each bid after unifying the foundations and criteria for comparing bids in accordance with the criteria included in the tender documents. It must also contain a recommendation to award the bid with the best terms and lowest price.

Article Seven

The Tenders and Auctions Board may assign a consulting party to carry out the evaluation or re-evaluation of bids, and the acting party shall bear the expenses of the assignment.

Article Eight

This decision shall be published in the Official Gazette, and shall be effective from the day following the date of its publication, and the concerned authorities must implement it, each within its jurisdiction.








