Resolution No. (1) of 2015

Concerning the procedures for internal government tenders, bids, purchases and sales

Chairman of the Tenders and Auctions Board:

'After reviewing Decree Law No. (36) of 2002 regulating government tenders, auctions, purchases and sales, as amended by Law No. 29 of 2010, especially Article (11) bis thereof, and Decree No. (37) of 2002, cissuing the executive regulations for the law regulating tenders, auctions, purchases and sales.

Governmental

After the approval of the Tenders and Auctions Board,

Decide the following:

Article one


1- The disposing authority undertakes internal purchasing and selling procedures in cases of purchase or sale that do not exceed their value

Estimated - 10,000 dinars according to the following:



- 2- The supplier or contractor is not required to provide an initial guarantee or performance guarantee in cases of purchase or sale whose estimated value does not exceed ten thousand dinars
- 3. In the event that the value of the offer to which it is decided to award exceeds the estimated value mentioned in Paragraph (1) of this Article, it is permissible to negotiate with the offeror to lower its price to the limits of the estimated value, without prejudice to the conditions

and requirements specified for purchase or sale.

'4- The managing authorities are keen to record all data and information related to purchases and sales whose estimated cost does not exceed 10 thousand dinars in the "Purchasing Procedures Register", and in particular the data and information specified in Article No. (8) of the Executive Regulations of the Law Regulating Government Tenders, Purchases, Auctions and Sales, The disposing authority enables the country's regulatory authorities, internal control authorities, and all parties permitted to view the purchase record under the provisions of Article (9) of the aforementioned executive regulations, to view this record upon the request of these parties.

second subject

41- In cases of purchase or sale whose estimated value is an amount of 10,000 dinars or more and does not exceed an amount of 25,000 dinars for ministries and government institutions and an amount of 50,000 dinars for companies, the disposing authorities carry out the purchase or sale procedures internally, provided that Commitment to the provisions of Decree Law No. (36) of 2002 regulating government tenders, auctions, purchases and sales, its amendments and its executive fregulations, and in particular the provisions of Article (4) of this Decree Law. This requires that the public tender or bidding method be followed by announcing it, and any of the other purchasing methods specified in this article shall not be followed except by virtue of a reasoned decision from the Tenders, Auctions, Purchases and Internal Sales Committee.

- If there are reasons for following the limited tender method, it must be ensured that an invitation is directed to all or as many suppliers
 or contractors as possible working in the type of activity subject to the tender and who are registered in the records of the managing,
 authority and the Council in accordance with the provisions of Article (44) of the Law Regulating Government Tenders, Auctions,
 Purchases and Sales
- 3- In the event that the value of the offer that the disposing authority deems to be awarded exceeds the amount of 25,000 dinars for ministries and government institutions, and 50,000 dinars for government companies, negotiations shall be made with the owner of this offer, and the award decision shall be taken by the Council if it is The offer value after negotiation is still

higher than this ceiling.

²4- The disposing entity must obtain the Council's prior approval to extend and renew contracts concluded internally if the cumulative value of the contract exceeds the ceiling amount specified for the internal contracting of this entity.

-H. The disposing entities are obligated to notify the Council of the list of their purchases and sales amounting to ,10,0000 dinars or more and not exceeding 25,000 dinars for ministries and government institutions and 50,000 dinars for government companies at least once every three months, provided that this list includes data. Recorded in the "Procurement Procedures Record" and shown in the form issued by the Council herein

The matter

Article Three

A committee shall be established in each exercising authority, called the Tenders, Auctions, Purchases and Internal Sales Committee, consisting of three or more members with experience and expertise. The competent minister or someone in his position shall select its membership. It shall be responsible for supervising all procedures for tenders, auctions, purchases and sales that take place internally. Specifically, receiving offers, evaluating them, making the reasoned decision to choose a contracting method other than the public tender method, making negotiation decisions, and awarding decisions to the winning bidders.

Article Four

It is not permissible to divide purchases or sales with the intention of circumventing the conditions, procedures, or other controls contained in the aforementioned decree law, or this decision, and the disposing authorities must group homogeneous needs that are united by a specific connection or a single goal to be purchased in one batch.

Article Five

The Tenders, Auctions, Procurement and Internal Sales Committee shall maintain a box (or more) in which to deposit the offers submitted by suppliers and contractors, provided that a specific and sufficient time is specified for submitting and receiving these offers, and that they are opened and recorded in the opening form, and that their presenters or their representatives are allowed to attend the opening session.
